Concept Map and Summary

Select a population and a related issue of interest to you. Some examples of topics are: teens and homelessness, teens and drug addiction, seniors and poverty, elder abuse, children and sexual abuse, families and violence, informal caregivers and burnout. The population and issue selected should be different than the one you are addressing in your clinical practicum.

Identify a question related to the topic.

Step 1: Research the topic. Preparation for concept map would include reading of at least **three (3) recent research based** articles. Using the Population Health Promotion Model (Hamilton and Bhatti, 1996) create a concept map depicting:

a) the most relevant determinants of health (root causes); and

b) action strategies being used to address the issue and/or strategies that could be used to address the issue.

c) the level at which the action strategies are being applied.

The concept map should be created on 8.5x11, or 8.5x14 size paper.

Step 2: Prepare a summary of the concept map discussing the issue which is no greater than four pages, excluding the cover page and references. Please describe the extent of the problem, as well as concisely outlining the relevant determinants of health and the strategies for health promotion from the Ottawa Charter, as well as the level at which these strategies are being applied. The APA 6th edition will guide the format for written assignments (include a reference list). Include this with your concept map.

Articles are research based with most being in the past five years.

Some examples of the concept map will be provided to the class.
